Do you know where the name Brentwood Estates came from?

Well, the Black family owned much of the property around Keller Town Center, including property in our neighborhood. In fact, until recently, the family maintained the ranch-style house built in 1970 on the top of the hill at 545 Rufe Snow. That house. on the right just before Keller Pointe, was demolished this year to begin construction on a new residential development. One of the Black sons was named Robert Brent Black.

The Blacks and the developer (Wayne Lee) combined Robert's middle name (Brent) with the word 'wood' since our neighborhood was heavily wooded. There you have it: Brentwood Estates!

One thing is certain about Brentwood Estates: our neighborhood is defined by its neighbors, and through the years we've had great families living here. This past year, we have welcomed new families to move our history forward. If you get a chance, offer them a warm welcome.

As a member of the Brentwood Estates Homeowners Association (BEHA) in good standing, you have the right to vote on actionable items brought before the neighborhood. Some of these are routine; for instance, the approval of the upcoming budget. You can vote either in person at BEHA meetings or by proxy. If you cannot attend the meeting in person, you can use your proxy card to designate someone to vote for you. Residents usually allow the BEHA secretary to vote for them. However, you can choose someone else, like another neighbor, to vote your proxy for you. What is important is that you VOTE! This past annual meeting we had a 40% participation rate of our neighborhood vote. We would like to see 100%.
